Dear Carlos,

You've heard the news: President Donald Trump has signed an executive order initiating an immediate freeze on persons entering the United States from seven countries: Iran, Iraq, Libya, Somalia, Sudan, Syria, and Yemen.

The order, "Protecting the Nation from Foreign Terrorist Entry into the United States," affects immigrant and non-immigrant visa orders and calls for the suspension of immigrant and non-immigrant individuals from entering the United States from the seven named nations for at least 90 days. Also under the order, current H-1B and other work visa holders who are currently traveling outside of the United States may not be allowed to re-enter the country to return home and to work.

Silicon Valley is just one of the areas to raise concerns, as the order affects many staff members of large tech companies. The CEOs of Microsoft, Apple, Netflix, Uber, Airbnb and Tesla Motors noted the policy would jeopardize their competitive quest for talent. According to USA Today, Google CEO Sundar Pichai condemned the order for potentially leaving some of their 200 affected employees stranded abroad.
