

Luego de que el presidente Donald Trump firmara una orden ejecutiva que promueve el veto a inmigrantes, la confusión en los fronterizos ha crecido ante el temor de que se les quite su visa al intentar ingresar a Estados Unidos.

Esto debido a que en los últimos días han estado circulando afirmaciones en redes sociales de que agentes del Departamento de Aduanas y Protección Fronteriza (CBP) están quitando visas a los extranjeros que crucen de noche.

"Eso es una mentira, nosotros no estamos quitando las visas por cruzar tarde. Hay tiendas que abren toda la noche y su visa de turistas les permite cruzar a comprar a la hora que sea", comentó Rubén Jáuregui, vocero de CBP en El Paso.

Aunque agregó que es verdad que se han quitado visas, el vocero negó que sea una "cacería" contra extranjeros y que sólo se trata de decomisos por "mal uso".

"Siempre le hemos quitado visas a la gente que hace mal uso de ellas. Por ejemplo, cuando alguien con visa de turista quiere vivir, trabajar o estudiar en Estados Unidos se las quitamos, porque la (visa) de turista obviamente no es para nada de eso", dijo Jáuregui.

Temor en redes sociales

Ante la incertidumbre, los fronterizos han externado sus preguntas a través de Facebook, donde algunos usuarios manifiestan que se trata de una "orden contra mexicanos", pero otros creen que "depende del *migra* que te revise".

Personas como Silvia Cueto aseguran tener conocidos quienes ya perdieron la visa por estas medidas.

"A mi amiga le quitaron el viernes su visa, que porque ya eran las 10 de la noche y era tarde para ir de compras", manifestó la mujer.

Por su parte Jáuregui contestó que este tipo de comentarios en redes sociales sólo causan "paranoia" entre la

gente, pero aseguró que nada es verdad.

"Todos dicen que al primo del abuelito del tío de la vecina le pasó, en realidad nadie conoce a nadie y sólo se dejan llevar por lo que dice la gente", comentó el vocero.

Las revisiones 'son las mismas'

Ante las largas filas que se han registrado en los últimos días, Jáuregui descartó que se deban a que los agentes sean más "estrictos".

"Las revisiones son exactamente las mismas, lo que pasa es que más gente está cruzando a cargar gasolina y de compras", dijo.

Jáuregui pidió a la comunidad no dejarse llevar por comentarios de redes sociales, ya que considera que solamente causan "temores" innecesarios.

They cross by gasoline and slow down the bridges: CBP

After President Donald Trump signed an executive order that promotes the veto of immigrants, confusion at the border has grown in the face of the fear that their visa will be taken away when they attempt to enter the United States.

This is because in recent days there have been circulating statements in social networks that agents of the Customs and Border Protection (CBP) are removing visas for foreigners crossing at night.

"That's a lie, we're not taking away visas for crossing late. There are stores that open all night and their tourist visa allows them to cross to buy at any time, "said Rubén Jáuregui, a spokesman for CBP in El Paso.

Although he added that it is true that they have removed visas, the spokesman denied that it is a "hunt" against foreigners and that it is only about seizures for "misuse".

"We have always taken visas from people who misuse them. For example, when someone with a tourist visa wants to live, work or study in the United States we take them away, because the tourist visa is obviously not at all, "said Jáuregui.

Fear in social networks

Faced with uncertainty, border people have expressed their questions through Facebook, where some users say that it is an "order against Mexicans", but others believe that "it depends on the mig that checks you."

People like Silvia Cueto claim to have acquaintances who have already lost their visa for these measures.

"My friend took her visa on Friday, because it was 10 o'clock at night and it was late to go shopping," said the woman.

Jáuregui replied that this type of comments in social networks only cause "paranoia" among people, but said nothing is true.

"Everybody says that the cousin of the grandfather of the neighbor's uncle happened to him, in fact no one knows anybody and they just let themselves be carried away by what people say," said the spokesman.

Reviews 'are the same'

Before the long lines that have registered in the last days, Jáuregui ruled that they are due to the agents are more "strict".

"The reviews are exactly the same, what happens is that more people are crossing to charge gas and shopping," he said.

Jáuregui asked the community not to be carried away by comments of social networks, since it considers that they only cause unnecessary "fears".

The best that we could determine was that this was the result of social media posts being circulated as fact but without any concrete substantiation, which is unfortunate.

If someone has suggested that this has occurred/is occurring I suggest that you demand that they present specific evidence so we can look into the matter and fully defend the allegation. This would include the name of the person making the claim (including their DOB), where this allegedly occurred as well as the date and time. The name of the CBP officer involved would also help.

Please do not accept a response of "fear of retaliation" as an excuse for someone not sharing specifics. This is a common excuse for not offering any concrete information which we can pursue and is a meritless concern. I have been in this position for more than 20 years and am not aware of a single case of retaliation occurring because someone stepped forward to complain about alleged unprofessional behavior or mistreatment.

Integrity is a core value of CBP's and is the cornerstone upon which CBP builds the foundation of public trust. CBP takes allegations involving officer conduct, integrity and professionalism very seriously. In fact we encourage people to report any misconduct to us so we can investigate https://www.cbp.gov/travel/customer-service/handle-complaints. In addition if you are told that the CBP officer would not provide their name this would also be untrue because all our personnel wear name tags.

Regarding your other question operations continue as usual without changes.

And by the way our agency is U.S. Customs and Border Protection not Customs and Border Patrol.

Quiere Trump excluir a mamás 'transfronterizas'

El presidente Donald Trump giró instrucciones al Departamento de Seguridad Nacional y al Departamento de Estado para que le informen sobre 'las medidas que están tomando para combatir el turismo de nacimientos', reportó The Washington Post.

Esto se refiere a las extranjeras que llegan a Estados Unidos para dar a luz a sus hijos con el fin de que obtengan la ciudadanía, una práctica que durante mucho tiempo ha indignado a conservadores republicanos.

Los documentos en borrador, filtrados por personas con conocimiento del tema, coinciden con la línea dura tocante a la inmigración que sigue la administración Trump. No se sabe aún cuándo se daría a conocer oficialmente la medida.

Defensores de los inmigrantes reaccionaron molestos ante los documentos en borrador.

'(Trump) está dirigiéndose a niños que son ciudadanos estadounidenses que en la escuela han tenido comidas más reducidas. Resulta asombrosa la profundidad del trastorno y el caos que Trump parece empeñado en provocar en nuestras comunidades', dijo Angela Kelley, asesora en materia de inmigración del Centro por el Progreso Estadounidense.

En El Paso, voceros de la Oficina de Aduanas y Protección Fronteriza (CBP), dijeron no haber recibido instrucciones de modificar su política de admisión a extranjeras embarazadas.

'Al igual que cualquier solicitante, el viajero debe demostrar que es ciudadano estadounidense o, si es extranjero, que ha superado todos los motivos de inadmisibilidad. No existe un motivo de inadmisibilidad dentro de la ley de inmigración estadounidense que prohíba el nacimiento de un niño en los Estados Unidos', dijo un funcionario de CBP.

La admisibilidad de un viajero se determina sobre la base de una inspección realizada por un oficial de CBP. Al igual que con cualquier viajero, el oficial de CBP examina si el viajero es o no admisible.

'Llegar a EU para dar a luz no hace, por sí sólo no es un hecho, para que un individuo sea inadmisible', dijo Roger Maier, portavoz de CBP en El Paso.

Explicó que aquellos que se presenten como visitantes temporales deben superar todos los motivos de inadmisibilidad, incluido el requisito de que el viajero no abandone su residencia en el extranjero, que sí tenga la intención de regresar, se pueda mantener y tenga la capacidad de pagar sus gastos en EU, incluyendo gastos médicos.

CBP reiteró que la obtención de cuidado médico es una actividad permitida dentro de la categoría de la visa de visitante temporal (B1 / B2), siempre y cuando el viajero tenga los medios para pagar los costos médicos asociados.

Sólo si la persona entra con la intención de permanecer más allá del período de tiempo asignado por su visa, o para que sus costos de parto sean pagados con fondos públicos, podría ser considerado inadmisible.

Turismo de parto, nada nuevo

Según expertos, por años el turismo de partos ha sido practicado por millones de mujeres alrededor del mundo que vienen en las últimas semanas de gestación para dar a luz aquí en El Paso.

Un niño nacido en EU se convierte automáticamente en ciudadano y, bajo la ley federal, cuando cumple 21 años puede patrocinar a sus familiares para que obtengan la residencia permanente y, en última instancia, la ciudadanía.

El Centro de Estudios sobre la Inmigración, organización que hace campaña contra esta práctica y que favorece más restricciones a la inmigración en general, estima que 40 mil mujeres visitan anualmente el país con este fin.

Ante una práctica común en la región fronteriza, las autoridades aseguran que la modalidad no rompe con las leyes estadounidenses actuales.

No es ilegal: médicos

En El Paso practican alrededor de 40 ginecoobstetras que atienden a madres embarazadas locales y visitantes, uno de ellos es el doctor Mario Nutis, quien asegura atiende aproximadamente 60 partos de madres mexicanas mensualmente aquí en la ciudad, modalidad que ha observado por años.

Afirma que la mayoría de ellas son profesionales con recursos económicos que saldan sus cuentas en efectivo y una vez que tienen sus hijos regresan a residir a México.

'Es muy común para un ginecoobstetra de El Paso atender madres mexicanas o de otras partes del mundo. Se piensa que estas madres quieren aprovecharse del sistema y no es así. La creencia es que tienen los niños en El Paso para que éstos reciban beneficios del Gobierno; sin embargo, aunque los pequeños sean estadounidenses si no residen aquí no pueden aplicar a dichas ayudas', aseguró Nutis.

El especialista dijo que la mayoría de sus pacientes extranjeras continúa viviendo en México con sus familias y tienen sus hijos en el país con el propósito de darles más opciones de un mejor futuro con la ciudadanía estadounidense

Pagan su deuda, la mayoría

En El Paso, la mayoría de los hospitales ofrecen programa de pagos por adelantado permitiéndoles a las madres planear con tiempo su parto y organizar sus finanzas.

Fuentes oficiales de los hospitales locales explicaron que estos servicios generalmente se ofrecen para personas que no cuentan con un seguro médico, que no habían sido creados para madres mexicanas especialmente y mucho menos promovían directamente el 'turismo de partos'.

De acuerdo con Nutis, la mayoría de sus pacientes vienen semanas antes de dar a luz, se quedan con algún acompañante, con familiares o rentan un apartamento o una habitación de hotel en la ciudad. La estadía de estos turistas fomenta la industria hotelera y restaurantera así como los negocios en general.

Las embarazadas que deciden dar a luz en El Paso, por lo general contactan a clínicas en el país que ofrecen este servicio, el cual incluye el parto o la cesárea, un par de consultas antes y después del alumbramiento la orientación para que el recién nacido obtenga, a la brevedad, la partida de nacimiento y el pasaporte americano para que retorne al país de sus padres.

Las pacientes compran un paquete que pagan antes de viajar al país, que además muestran como constancia a los Servicios de Inmigración cuando entran, explicó Rodolfo Gámez, vocero de la clínica Doctores para Ti, en El Paso, que brinda apoyo a las mujeres embarazadas extranjeras que vienen a la ciudad a dar a luz.

'La gente cree que es ilegal, pero es completamente legal. Las personas pueden comprobar que tienen solvencia económica para pagar este parto, es la mejor manera de entrar al país', señala Gámez.

Legalmente no hay inconvenientes que veten esta práctica. A menos que la persona no pague la cuenta del hospital, sería un delito. (Con información de The Washington Post)

Trump wants to exclude 'cross-border' Juliana Henao / Diego Murcia El Diario of El Paso | Friday 03 February 2017 | 00:01:00 hrs

President Donald Trump has directed the Department of Homeland Security and the State Department to report on "the steps they are taking to combat birth tourism," the Washington Post reported.

This refers to foreigners who come to the United States to give birth to their children in order to gain citizenship, a practice that has long angered conservative Republicans.

The draft documents, leaked by people with knowledge of the subject, match the hard line regarding immigration that follows the Trump administration. It is not yet known when the measure would be officially announced.

Immigrant advocates reacted with annoyance to the draft documents.

'(Trump) is addressing children who are US citizens who have had smaller meals at school. It's amazing the

depth of the upheaval and the chaos that Trump seems intent on provoking in our communities, "said Angela Kelley, the Center's advisor on immigration for US Progress.

In El Paso, spokespersons for the Customs and Border Protection Office (CBP), said they had not been instructed to change their policy of admission to pregnant foreigners.

'Like any applicant, the traveler must prove that he is a US citizen or, if he is a foreigner, that he has exceeded all grounds of inadmissibility. There is no ground of inadmissibility under US immigration law that prohibits the birth of a child in the United States, "said a CBP official.

The admissibility of a traveler is determined on the basis of an inspection by a CBP officer. As with any traveler, the CBP officer examines whether or not the traveler is admissible.

"Getting to the US to give birth does not, in and of itself is not a fact, for an individual to be inadmissible," said Roger Maier, CBP spokesman in El Paso.

He explained that those who present themselves as temporary visitors must overcome all grounds of inadmissibility, including the requirement that the traveler does not leave his residence abroad, that he intends to return, can maintain himself and has the capacity to pay his US expenses, including medical expenses.

CBP reiterated that obtaining medical care is an activity allowed within the category of temporary visitor visa (B1 / B2), provided that the traveler has the means to pay associated medical costs.

Only if the person enters with the intention to remain beyond the period of time allotted for his visa, or for his costs of childbirth to be paid with public funds, could be considered inadmissible.

Birth tourism, nothing new

According to experts, for years childbirth tourism has been practiced by millions of women around the world who come in the last weeks of gestation to give birth here in El Paso.

A child born in the US automatically becomes a citizen and, under federal law, when he turns 21, he can sponsor his family members to obtain permanent residence and, ultimately, citizenship.

The Center for Immigration Studies, an organization that campaigns against this practice and which favors more restrictions on immigration in general, estimates that 40,000 women visit the country annually for this purpose.

Before a common practice in the border region, the authorities assure that the modality does not break with the current American laws.

It's Not Illegal: Doctors

In El Paso, about 40 obstetricians and obstetricians attend local pregnant moms and visitors, one of them is Dr. Mario Nutis, who assists about 60 deliveries of Mexican mothers monthly here in the city, a mode he has observed for years.

He states that most of them are professionals with economic resources who leave their accounts in cash and once they have their children return to reside in Mexico.

"It is very common for an OB / GYN to attend Mexican mothers or from other parts of the world. It is thought

that these mothers want to take advantage of the system and it is not. The belief is that they have the children in El Paso so that they receive benefits from the Government; However, even if the children are Americans if they do not reside here they can not apply to such aid, "said Nutis.

The specialist said that most of his foreign patients continue to live in Mexico with their families and have their children in the country in order to give them more options for a better future with US citizenship.

They pay their debt, the majority

In El Paso, most hospitals offer an advance payment program allowing mothers to plan their childbirth in time and organize their finances.

Official sources from local hospitals explained that these services are generally offered for people who do not have health insurance, who were not specially created for Mexican mothers and much less promoted 'birth tourism' directly.

According to Nutis, most of her patients come weeks before giving birth, stay with a companion, with relatives or rent an apartment or a hotel room in the city. The stay of these tourists foments the hotel industry and restaurant as well as the businesses in general.

Pregnant women who decide to give birth in El Paso usually contact clinics in the country that offer this service, which includes delivery or cesarean section, a couple of consultations before and after delivery, orientation for the newborn Obtain, as soon as possible, the birth certificate and the American passport to return to the country of his parents.

The patients buy a package they pay before traveling to the country, which also show the Immigration Services as a record when they enter, explained Rodolfo Gámez, a spokesman for the clinic Doctores para Ti in El Paso, which provides support to foreign pregnant women Who come to the city to give birth.

"People think it's illegal, but it's completely legal. People can prove that they have the economic solvency to pay for this birth, it is the best way to enter the country, "says Gámez.

Legally there are no drawbacks that veto this practice. Unless the person does not pay the hospital bill, it would be a crime. (With information from The Washington Post)




The reporter did ask one speaker about specific allegations and received nothing. There was a lot of "we are hearing" and "maybe happening" type comments but nothing firm and concrete.

Quiere Trump excluir a mamás 'transfronterizas'

El presidente Donald Trump giró instrucciones al Departamento de Seguridad Nacional y al Departamento de Estado para que le informen sobre 'las medidas que están tomando para combatir el turismo de nacimientos', reportó The Washington Post.

Esto se refiere a las extranjeras que llegan a Estados Unidos para dar a luz a sus hijos con el fin de que obtengan la ciudadanía, una práctica que durante mucho tiempo ha indignado a conservadores republicanos.

Los documentos en borrador, filtrados por personas con conocimiento del tema, coinciden con la línea dura tocante a la inmigración que sigue la administración Trump. No se sabe aún cuándo se daría a conocer oficialmente la medida.

Defensores de los inmigrantes reaccionaron molestos ante los documentos en borrador.

'(Trump) está dirigiéndose a niños que son ciudadanos estadounidenses que en la escuela han tenido comidas más reducidas. Resulta asombrosa la profundidad del trastorno y el caos que Trump parece empeñado en provocar en nuestras comunidades', dijo Angela Kelley, asesora en materia de inmigración del Centro por el Progreso Estadounidense.

En El Paso, voceros de la Oficina de Aduanas y Protección Fronteriza (CBP), dijeron no haber recibido instrucciones de modificar su política de admisión a extranjeras embarazadas.

'Al igual que cualquier solicitante, el viajero debe demostrar que es ciudadano estadounidense o, si es extranjero, que ha superado todos los motivos de inadmisibilidad. No existe un motivo de inadmisibilidad dentro de la ley de inmigración estadounidense que prohíba el nacimiento de un niño en los Estados Unidos', dijo un funcionario de CBP.

La admisibilidad de un viajero se determina sobre la base de una inspección realizada por un oficial de CBP. Al igual que con cualquier viajero, el oficial de CBP examina si el viajero es o no admisible.

'Llegar a EU para dar a luz no hace, por sí sólo no es un hecho, para que un individuo sea inadmisible', dijo Roger Maier, portavoz de CBP en El Paso.

Explicó que aquellos que se presenten como visitantes temporales deben superar todos los motivos de inadmisibilidad, incluido el requisito de que el viajero no abandone su residencia en el extranjero, que sí tenga la intención de regresar, se pueda mantener y tenga la capacidad de pagar sus gastos en EU, incluyendo gastos médicos.

CBP reiteró que la obtención de cuidado médico es una actividad permitida dentro de la categoría de la visa de visitante temporal (B1 / B2), siempre y cuando el viajero tenga los medios para pagar los costos médicos asociados.

Sólo si la persona entra con la intención de permanecer más allá del período de tiempo asignado por su visa, o para que sus costos de parto sean pagados con fondos públicos, podría ser considerado inadmisible.

Turismo de parto, nada nuevo

Según expertos, por años el turismo de partos ha sido practicado por millones de mujeres alrededor del mundo que vienen en las últimas semanas de gestación para dar a luz aquí en El Paso.

Un niño nacido en EU se convierte automáticamente en ciudadano y, bajo la ley federal, cuando cumple 21 años puede patrocinar a sus familiares para que obtengan la residencia permanente y, en última instancia, la ciudadanía.

El Centro de Estudios sobre la Inmigración, organización que hace campaña contra esta práctica y que favorece más restricciones a la inmigración en general, estima que 40 mil mujeres visitan anualmente el país con este fin.

Ante una práctica común en la región fronteriza, las autoridades aseguran que la modalidad no rompe con las leyes estadounidenses actuales.

No es ilegal: médicos

En El Paso practican alrededor de 40 ginecoobstetras que atienden a madres embarazadas locales y visitantes, uno de ellos es el doctor Mario Nutis, quien asegura atiende aproximadamente 60 partos de madres mexicanas mensualmente aquí en la ciudad, modalidad que ha observado por años.

Afirma que la mayoría de ellas son profesionales con recursos económicos que saldan sus cuentas en efectivo y una vez que tienen sus hijos regresan a residir a México.

'Es muy común para un ginecoobstetra de El Paso atender madres mexicanas o de otras partes del mundo. Se piensa que estas madres quieren aprovecharse del sistema y no es así. La creencia es que tienen los niños en El Paso para que éstos reciban beneficios del Gobierno; sin embargo, aunque los pequeños sean estadounidenses si no residen aquí no pueden aplicar a dichas ayudas', aseguró Nutis.

El especialista dijo que la mayoría de sus pacientes extranjeras continúa viviendo en México con sus familias y tienen sus hijos en el país con el propósito de darles más opciones de un mejor futuro con la ciudadanía estadounidense.

Pagan su deuda, la mayoría

En El Paso, la mayoría de los hospitales ofrecen programa de pagos por adelantado permitiéndoles a las madres planear con tiempo su parto y organizar sus finanzas.

Fuentes oficiales de los hospitales locales explicaron que estos servicios generalmente se ofrecen para personas que no cuentan con un seguro médico, que no habían sido creados para madres mexicanas especialmente y mucho menos promovían directamente el 'turismo de partos'.

De acuerdo con Nutis, la mayoría de sus pacientes vienen semanas antes de dar a luz, se quedan con algún acompañante, con familiares o rentan un apartamento o una habitación de hotel en la ciudad. La estadía de estos turistas fomenta la industria hotelera y restaurantera así como los negocios en general.

Las embarazadas que deciden dar a luz en El Paso, por lo general contactan a clínicas en el país que ofrecen este servicio, el cual incluye el parto o la cesárea, un par de consultas antes y después del alumbramiento la orientación para que el recién nacido obtenga, a la brevedad, la partida de nacimiento y el pasaporte americano para que retorne al país de sus padres.

Las pacientes compran un paquete que pagan antes de viajar al país, que además muestran como constancia a los Servicios de Inmigración cuando entran, explicó Rodolfo Gámez, vocero de la clínica Doctores para Ti, en El Paso, que brinda apoyo a las mujeres embarazadas extranjeras que vienen a la ciudad a dar a luz.

'La gente cree que es ilegal, pero es completamente legal. Las personas pueden comprobar que tienen solvencia económica para pagar este parto, es la mejor manera de entrar al país', señala Gámez.

Legalmente no hay inconvenientes que veten esta práctica. A menos que la persona no pague la cuenta del hospital, sería un delito. (Con información de The Washington Post)

Trump wants to exclude 'cross-border'

President Donald Trump has directed the Department of Homeland Security and the State Department to report on "the steps they are taking to combat birth tourism," the Washington Post reported.

This refers to foreigners who come to the United States to give birth to their children in order to gain citizenship, a practice that has long angered conservative Republicans.

The draft documents, leaked by people with knowledge of the subject, match the hard line regarding immigration that follows the Trump administration. It is not yet known when the measure would be officially announced.

Immigrant advocates reacted with annoyance to the draft documents.

'(Trump) is addressing children who are US citizens who have had smaller meals at school. It's amazing the depth of the upheaval and the chaos that Trump seems intent on provoking in our communities, "said Angela Kelley, the Center's advisor on immigration for US Progress.

In El Paso, spokespersons for the Customs and Border Protection Office (CBP), said they had not been instructed to change their policy of admission to pregnant foreigners.

'Like any applicant, the traveler must prove that he is a US citizen or, if he is a foreigner, that he has exceeded all grounds of inadmissibility. There is no ground of inadmissibility under US immigration law that prohibits the birth of a child in the United States, "said a CBP official.

The admissibility of a traveler is determined on the basis of an inspection by a CBP officer. As with any traveler, the CBP officer examines whether or not the traveler is admissible.

"Getting to the US to give birth does not, in and of itself is not a fact, for an individual to be inadmissible," said Roger Maier, CBP spokesman in El Paso.

He explained that those who present themselves as temporary visitors must overcome all grounds of inadmissibility, including the requirement that the traveler does not leave his residence abroad, that he intends to return, can maintain himself and has the capacity to pay his US expenses, including medical expenses.

CBP reiterated that obtaining medical care is an activity allowed within the category of temporary visitor visa (B1 / B2), provided that the traveler has the means to pay associated medical costs.

Only if the person enters with the intention to remain beyond the period of time allotted for his visa, or for his costs of childbirth to be paid with public funds, could be considered inadmissible.

Birth tourism, nothing new

According to experts, for years childbirth tourism has been practiced by millions of women around the world who come in the last weeks of gestation to give birth here in El Paso.

A child born in the US automatically becomes a citizen and, under federal law, when he turns 21, he can sponsor his family members to obtain permanent residence and, ultimately, citizenship.

The Center for Immigration Studies, an organization that campaigns against this practice and which favors more restrictions on immigration in general, estimates that 40,000 women visit the country annually for this purpose.

Before a common practice in the border region, the authorities assure that the modality does not break with the current American laws.

It's Not Illegal: Doctors

In El Paso, about 40 obstetricians and obstetricians attend local pregnant moms and visitors, one of them is Dr. Mario Nutis, who assists about 60 deliveries of Mexican mothers monthly here in the city, a mode he has observed for years.

He states that most of them are professionals with economic resources who leave their accounts in cash and once they have their children return to reside in Mexico.

"It is very common for an OB / GYN to attend Mexican mothers or from other parts of the world. It is thought that these mothers want to take advantage of the system and it is not. The belief is that they have the children in El Paso so that they receive benefits from the Government; However, even if the children are Americans if they do not reside here they can not apply to such aid, "said Nutis.

The specialist said that most of his foreign patients continue to live in Mexico with their families and have their children in the country in order to give them more options for a better future with US citizenship.

They pay their debt, the majority

In El Paso, most hospitals offer an advance payment program allowing mothers to plan their childbirth in time and organize their finances.

Official sources from local hospitals explained that these services are generally offered for people who do not have health insurance, who were not specially created for Mexican mothers and much less promoted 'birth tourism' directly.

According to Nutis, most of her patients come weeks before giving birth, stay with a companion, with relatives or rent an apartment or a hotel room in the city. The stay of these tourists foments the hotel industry and restaurant as well as the businesses in general.

Pregnant women who decide to give birth in El Paso usually contact clinics in the country that offer this service, which includes delivery or cesarean section, a couple of consultations before and after delivery, orientation for the newborn Obtain, as soon as possible, the birth certificate and the American passport to return to the country of his parents.

The patients buy a package they pay before traveling to the country, which also show the Immigration Services as a record when they enter, explained Rodolfo Gámez, a spokesman for the clinic Doctores para Ti in El Paso, which provides support to foreign pregnant women Who come to the city to give birth.

"People think it's illegal, but it's completely legal. People can prove that they have the economic solvency to pay for this birth, it is the best way to enter the country, "says Gámez.

Legally there are no drawbacks that veto this practice. Unless the person does not pay the hospital bill, it would be a crime. (With information from The Washington Post)



On January 27, 2017, President Donald Trump issued Executive Order: *Protecting the Nation from Foreign Terrorist Entry into the United States*. It is the policy of the United States to protect its citizens from foreign nationals who intend to commit terrorist attacks in the United States; and to prevent the admission of foreign nationals who intend to exploit United States immigration laws for malevolent purposes.

As we push forward in our efforts to protect our Nation, OFO Operations will require daily reporting on our activities as related to this Executive Order. Reporting will include encounters in the air, land and sea environments with anyone who arrives into the U.S. from the seven (7) countries (Iran, Iraq, Libya, Somalia, Sudan, Syria and Yemen) that meets the criteria outlined in the Executive Order and the instructions issued to the field by Admissibility and Passenger Programs.

Using the attached spreadsheet, data should be captured daily for the 24-hour time period beginning at 0300 (EST) – and ending at 0259 hours (EST). By 0500 hours (EST) daily, each Field Office is required to submit their data from the previous 24-hours to OFO Field Liaison (b)(7)(E) Reports must be submitting using the attached Microsoft Excel template document. Field Liaison will consolidate these reports into a final report senior CBP and DHS leadership.

WASHINGTON - Upon issuance of the court orders yesterday, U.S. Customs and Border Protection (CBP) immediately began taking steps to comply with the orders. Concurrently, the Department of Homeland Security continues to work with our partners in the Departments of Justice and State to implement President Trump's executive order on protecting the nation from foreign terrorist entry into the United States.

We are committed to ensuring that all individuals affected by the executive orders, including those affected by the court orders, are being provided all rights afforded under the law. We are also working closely with airline partners to prevent travelers who would not be granted entry under the executive orders from boarding international flights to the U.S. Therefore, we do not anticipate that further individuals traveling by air to the United States will be affected.

As Secretary Kelly previously stated, in applying the provisions of the president's executive order, the entry of lawful permanent residents is in the national interest. Accordingly, absent significant derogatory information indicating a serious threat to public safety and welfare, lawful permanent resident status will be a dispositive factor in our case-bycase determinations.

We are and will remain in compliance with judicial orders. We are and will continue to enforce President Trump's executive order humanely and with professionalism. DHS will continue to protect the homeland.

NBC News.com - White House Floats 20 Percent Tax on Mexican Imports to Pay for Border Wall

NBC News reports President Donald Trump has not formally proposed a 20 percent tax on Mexican imports to pay for his controversial border wall and is instead considering it among a series of options, White House spokesman Sean Spicer said Thursday. "The goal today is not to be prescriptive. It's to basically say: Hey, here is a way in which the wall can be paid for extremely easy and not say 'this is what we're doing,'" Spicer told reporters. "This is not what we're rolling out."

CNN.com - Mexican president cancels meeting with Trump

CNN reports Mexican President Enrique Peña Nieto on Thursday canceled a meeting with U.S. President Donald Trump that had been set for next week after renewed tensions erupted over Trump's plan to build a wall on the border. "This morning we have informed the White House that I will not attend the meeting scheduled for next Tuesday with the POTUS," Peña Nieto tweeted.

Biometric Update.com - Trump's executive order on immigration addresses biometric entry-exit tracking system

Biometric Update reports President Donald Trump signed an executive order Wednesday which includes a series of initiatives to address immigration, including a proposal to establish a national biometric ID program for non-citizens entering and leaving the U.S., according to a report by Payments Source. According to a draft executive order leaked to civil rights advocates and obtained by The Washington Post, one of the measures of the executive order calls for an "Expedited Completion of Biometric Entry-Exit Tracking System". Section 8 of the executive order draft reads: "The Secretary of DHS shall expedite the completion and implementation of biometric entry-exit tracking system for all travelers to the U.S., as recommended by the National Commission on Terrorist Attacks upon the U.S."

Federal Soup.com - CBP gets personnel boost in executive order

Federal Soup reports following through on his campaign promise to tackle immigration, Donald Trump has issued an executive order outlining his immigration plan, which includes a boost in personnel for one federal agency. CBP will need to hire 5,000 additional Border Patrol agents as part of the executive order issued on Jan. 25. The order also states that all necessary action must be taken by the CBP commissioner to "ensure that such agents enter on duty and are assigned to duty stations as soon as is practicable."

Washington Post.com - Draft executive order would begin 'extreme vetting' of immigrants and visitors to the U.S.

Washington Post reports the Trump administration plans to start vetting would-be immigrants and visitors to the United States based partly on their opinions and ideology, and will immediately cease the resettlement of Syrian refugees in the United States, according to a draft executive order leaked Wednesday to civil rights advocates and obtained by The Washington Post. The order, if enacted, would signal the beginning of the "extreme vetting" that President Trump promised on the campaign trail, as well as partial implementation of the "Muslim ban," according to civil rights advocates.

USA TODAY.com - Security shortcut Clear expands to more airports

USA TODAY reports thanks to TSA PreCheck, Global Entry and a variety of other programs that pre-vet travelers, 12 million people are now eligible to access the expedited screening lanes at U.S. airports. But even with increased TSA staffing levels and the addition of automated screening lanes at some airports, many trusted travelers still end up waiting in long lines to get their IDs checked by TSA before they can even gain access to the expedited lanes.

Tucson.com - More drug profits slipping into Mexico as border seizures plummet

(b)(6), (b)(7)(C) daughter needed braces, so she decided to smuggle drug profits into Mexico for a cartel. The Chandler resident was caught with \$9,998 in her <u>purse and wallet</u> as she drove through the Nogales port of entry on March 15, U.S. District Court records show. (b)(6), (b)(7)(C), 45, told customs officers she picked up the cash from a man in a Costco parking lot in Mesa. She was supposed to deliver it to an ice cream shop in Sonora in exchange for the down payment on her daughter's orthodontia. The seized money was just below the \$10,000 cash reporting requirement, a tool used by CBPO's to prevent illicit cash smuggling. But as (b)(6), (b)(7)(C) case shows, CBP officers also can seize any amount of money if they believe it's the result of illegal activity.

Star Herald.com - U.S. Senator Deb Fischer seeks details on immigration information collection

Star Herald reports U.S. Senator Deb Fischer (R-Neb.) today sent a letter to DHS Secretary John Kelly asking for details about the new administration's plan to collect information on immigrants entering and exiting the country. In the letter, Fischer asks three specific questions regarding the administration's efforts to keep our country safe by establishing a comprehensive biometric entry-exit system.

DVIDShub.net - Trusted Traveler Program

DVIDS reports as of Dec. 1, 2016, Holloman Air Force Base, N.M. adjusted its security policies by adopting the Trusted Traveler Program. 





Effective immediately, Canadian Landed Immigrants that are citizens of Iran, Iraq, Libya, Somalia, Sudan, Syria and Yemen with a valid U.S. Visa may be considered for an exemption of the 212(f) bar under Section 3(g) of the President's Executive Order if and only if the person satisfies the following conditions:

- Proof to the satisfaction of the inspection Officer of person's Landed Immigrant Status in Canada;
- 2. Possession of a valid U.S. visa;
- 3. Travel that originates in Canada;
- 4. From only a pre-clearance airport; or
- 5. Applying for admission at a land border port of entry;
- 6. And the applicant is otherwise admissible.

The admission of such individuals must be in the national interest of the United States. Prior to any such admission, each individual must be subjected to a thorough examination by an immigration officer, to include CBP conduct of:


