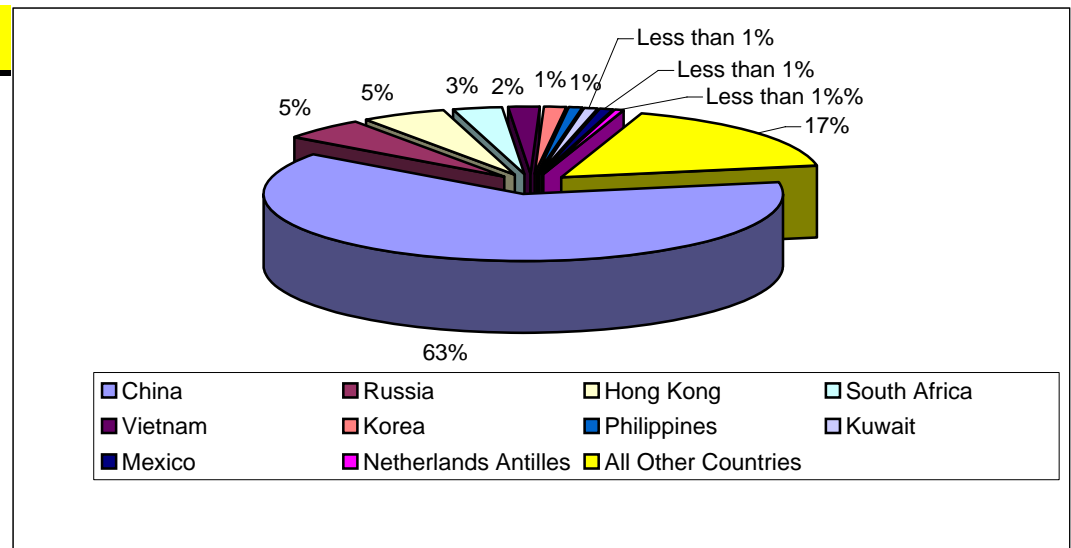

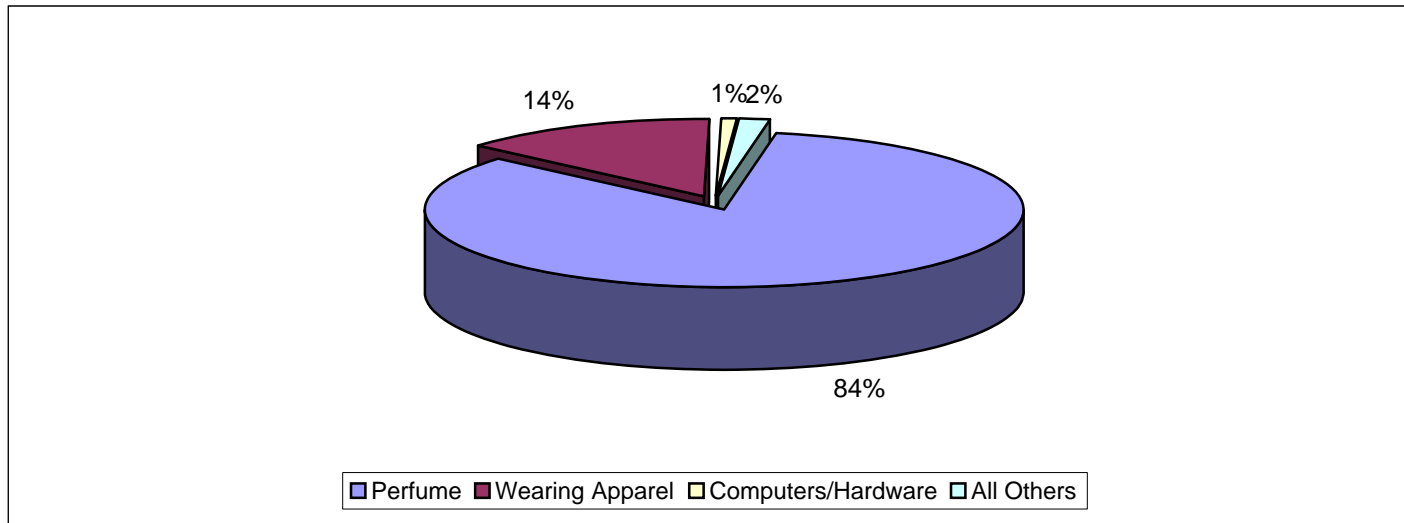

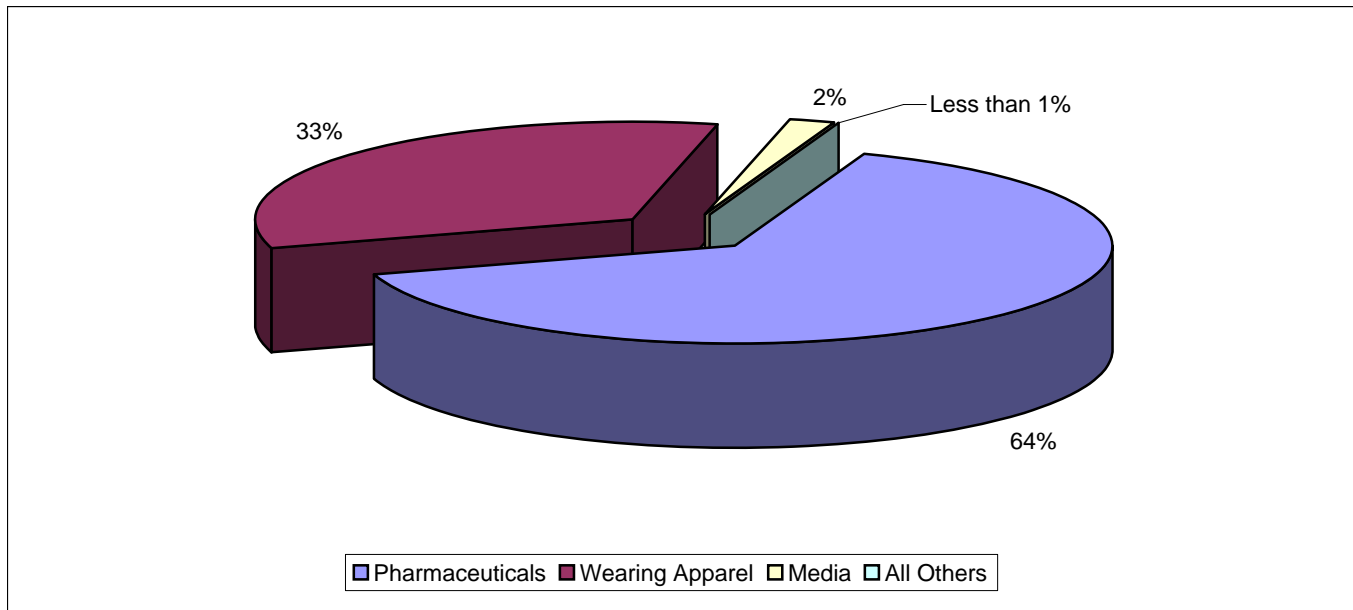

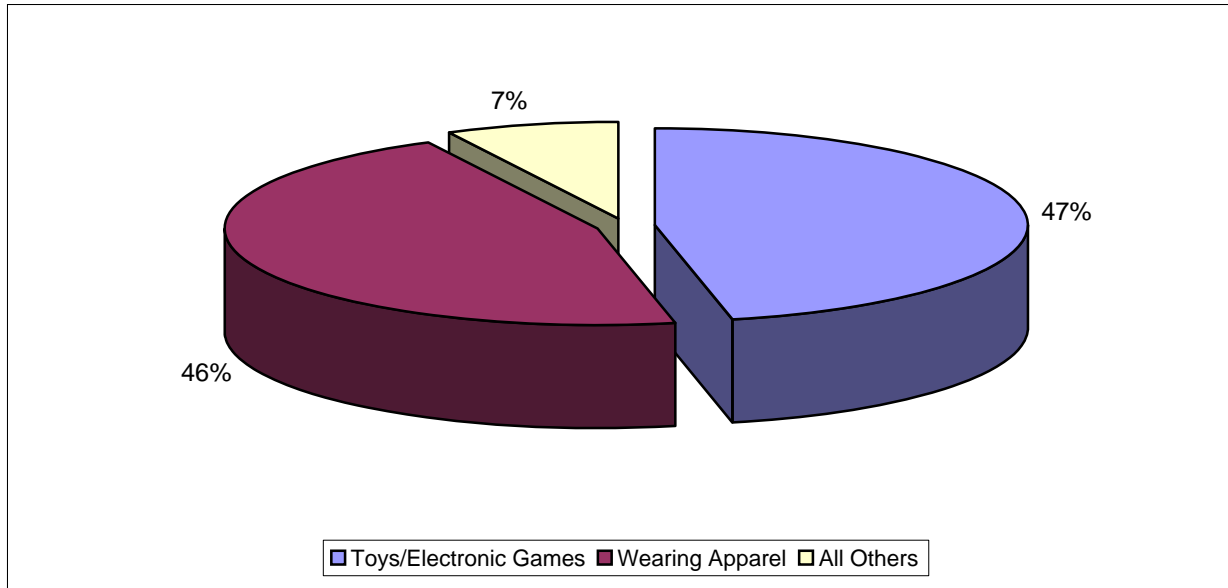

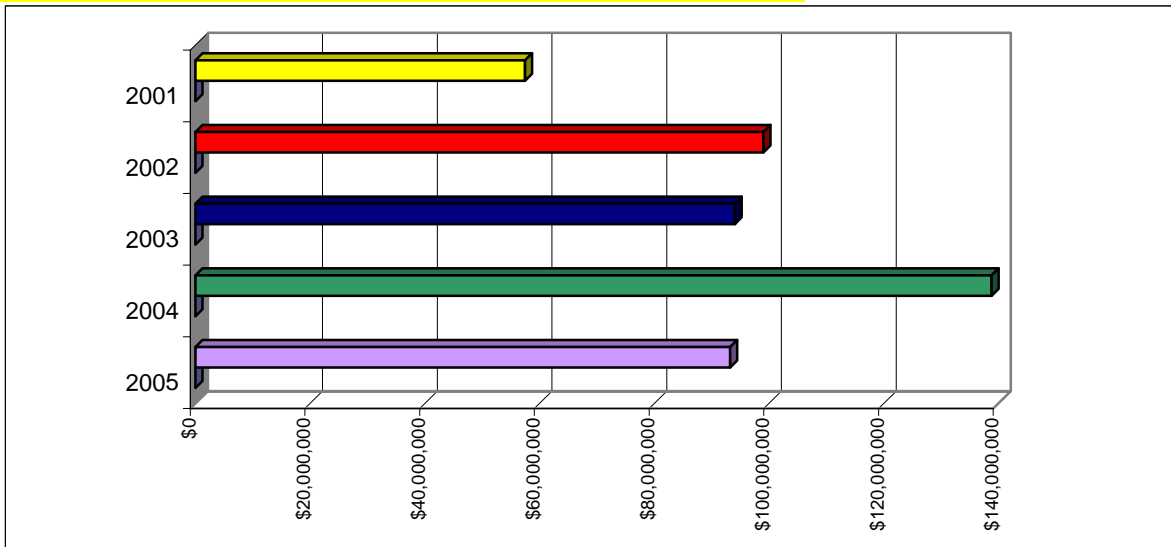

Comparison of Yearly Domestic Values of IPR Seizures

The value of IPR seizures in FY 2005 decreased by 33%, from the value in FY 2004. The FY 2005 value is very similar to those in FY 2003 and FY 2004.

Comparison of Yearly Seizure Totals

The seizure total reflects a 10.5% increase in the number of seizures from fiscal year 2004 to 2005, and is the highest number of seizures in the history of Customs/Dept. of Homeland Security.
