APHIS ACE CORE Message Set U.S. Department of Agriculture - Animal and Plant Health Inspection Service Our Mission - To protect the health and value of American agriculture and natural resources.

Background

In 2006 Congress passed the Safe Port Act which required all federal agencies to utilize the Automated Commercial Environment (ACE), International Trade Data System (ITDS), "single window" environment to facilitate the import process. Furthermore, in February 2014 the president of the United States signed the 21st Century Trade Facilitation executive order which mandated that all partner government agencies (PGAs) implement the "single window" by December 2016. The objectives of single window concept are: 1) Rapid availability of data that allows the government to efficiently identify commodity risk and make near real-time regulatory decisions. 2) Reduction in paper and increased electronic communications between trade and regulatory agencies which facilitates the import process. 3) Assists industry to comply with government regulations 4) Increases business process efficiency and reduces costs to government and industry.

Appendix Overview

The Appendix APH-A: APHIS Supplemental Trade Guide is primarily designed for filers that report APHIS Message sets on behalf of Importers. The guide is essentially a "job aid" aimed at separating the operational data entry concepts from the technical aspects of the APHIS Message sets. APHIS developed the material during the "optional" reporting phase of the APHIS Message Set initiative due to positive feedback received regarding information communicated via the [APHIS] <u>ACE.ITDS@aphis.usda.gov</u> service account. Much of this information was generated as a result of questions or recommendations by trade to produce material explaining the APHIS Message Set in a less technical way. Recommendations from trade also encouraged APHIS to cross reference key pieces of the APHIS Message Set design. This included cross referencing Harmonized Tariff Schedule (HTS) code with record lines like PG01 (APHIS Programs) and PG10 (APHIS Commodity Category Types).



Programs

The APHIS Core Message Set includes Plant Protection & Quarantine (APQ), Veterinary Services (AVS), Biological Regulatory Services (ABS), and Animal Care (AAC) programs. Each program houses their respective PG10 Category Type Code. Information needed for importation and to correctly regulate and safeguard agriculture products and related products are provided by Licenses, Permits, Certificates, and Other (LPCOs) documents.







Section I - Admissibility

The APHIS ACE Support Desk aids with submitting APHIS Core Message Sets in the ACE system by reviewing APHIS Message Sets, explaining error codes and flags, providing disclaim guidance, and answering general Message Set questions. The APHIS ACE Support Desk does not provide comprehensive support for questions associated with commodity admissibility. Filers are encouraged to work directly with Importers when determining if LPCO's are required as a condition of entry. Questions and concerns regarding admissibility or if you are unsure if your product requires a LPCO (License, Permit, Certificate, Other) visit the resources below.

Filers may use the <u>Harmonized Tariff Code Master Correlation Table for APHIS Core Message Set</u> to look up particular Harmonized Tariff Schedule (HTS) codes and find information that will help in identifying how the commodity is flagged and whether a message set will be required or can be disclaimed. In the case of an HTS not coming up as flagged within the HTS Correlation Table, you can potentially Disclaim "A" -- note though that APHIS may have missed some flags, so it is still the responsibility of the Importer / Filer to know if APHIS regulates the commodity. More information on disclaims can be found on section IV of this document.





The guidance for when to file an APHIS Core message set is based on flag and admissibility requirements. For HTS codes flagged AQ2 (data is required) a message set must be filed. For HTS codes flagged AQ1 (data may be required) or AQX (Warning) it is dependent on the presence of a license, permit, certificate or other (LPCO) document for admissibility. If your products do not require a LPCO then you may disclaim A (product not regulated by APHIS) or disclaim B (per agency guidance). For shipments that do require a LPCO a message set needs to be filed. More information on LPCOs can be found on section VII of this document.

Please know that no admissibility regulations have changed with the APHIS Core message set; if you haven't needed a LPCO in the past, the same would continue to be true now.

When a Message Set is required, guidance on how to file a message set within ACE, can be found within the <u>APHIS ACE PGA Message Set Implementation Guide</u>. This guide provides step by step direction on filing a Message Set as well as illustrating different examples/flow charts. Section II - Plant Inspection Stations

USDA-APHIS-PPQ has 16 <u>plant inspection stations</u> in the U.S. located at or near major international airports and seaports. Plant inspection stations (PIS) process and inspect propagative material, which includes imported plants for planting, seeds, any plant part capable for propagation, as well as other regulated plant material, and live organisms to determine admissibility and prevent the entry of exotic pests into the United States. Most propagative plant imports move forward to the PIS at the first port of entry, or nearest PIS upon arrival. Generally, CBP Agriculture processes and inspects twelve or fewer plants, seeds, as well as most Canadian origin plants at the first port of arrival, but there are exceptions. Exceptions where Canadian origin plants or seeds must be sent to USDA APHIS Inspection Stations include:

- Abelmoschus spp. (okra) seeds for planting (require treatment as a condition of entry; see Abelmoschus spp. in Lists of Plants for Planting)
- Hibiscus spp. (kenaf) seeds for planting (require treatment as a condition of entry; see Hibiscus spp. in Lists of Plants for Planting)
- Plants originating in a third country that are not considered to be from Canada (see Plants for Planting Considered As Being from Canada)

USDA APHIS Plant Inspection Stations process and inspect thirteen or more plants, all tree seeds, Small Lot of Seed Permit seeds, post-entry plant material, Controlled Import Permit shipments, and imports with special restrictions. Special restrictions may include requirements such as a permit, quarantine, treatment, or ESA or CITES documentation. Propagative material must be accompanied by a phytosanitary certificate from the country of origin showing that the imported commodity meets entry requirements for the United States. The USDA-APHIS-PPQ Plant Inspection Stations use the Agricultural Risk Management (ARM) system which is a downstream inspection recording system capable of communicating directly with ACE. When appropriate ARM communicates the validity of this data back to trade via SO70 [type] messaging. Overarchingly, ARM is utilized to support the operational and analytical needs of USDA APHIS and is leveraged to track, manage, and record inspections associated with live plant (AP0400) importations into the United States. The major focus of the system is to facilitate the inspection process by allowing APHIS officers to record their inspections, laboratory findings, and actions more efficiently. Inspection data includes (but is not limited to) information about the inspection location, shipper, county of origin and destination of the shipment, as well as the shipment mode of transportation, commodity, and officer(s) conducting the inspections. If pests are detected, information is also collected concerning the identification of the pest and/or disease. Diagnostic [laboratory] tests may be initiated leading to a final identification of the intercepted pest and/or disease, as well as a determination of the corrective actions necessary (e.g., treatment, destruction, or re-export). A taxonomic list of valid scientific names for propagative plant commodities can be found here: USDA APHIS | <u>Propagative Name Validation List</u>.

Plant Inspection Stations highly recommend transmitting the grower (code: DFI) name in the APHIS Core Message Set and selecting A02 = Plant Inspection Station, as the agency processing code. Including shipment paperwork with Digital Image Service (DIS) utilizing the appropriate USDA-APHIS DIS codes is important to expedite document review and clearance. The following DIS codes are used for APHIS Message Set filings:

- APH01: Certificates Issued by Foreign Governments, Phytosanitary Certificates, Health Certificates, Meat Certificates, Sanitary Certificates, Treatment Certificates, Foreign Certificate of Inspection, Certificate of Origin, etc.
- APH02: APHIS Supporting Documents (Commercial Invoices, Packing Lists, Arrival Notifications, Declarations etc.)
- APH03: APHIS Permits, Applications, notifications, and Letters

DIS instructions can be found on the <u>CBP Document Image System (DIS) Implementation Guide</u> and Section VII -LPCO Guidance/ DIS Transmission section of this guide.

Entry Type 61 – Immediate Transportation (IT)

Entry type 61 is used for in-bond movement of cargo from the port of arrival to another U.S. port. Although ACE does not currently allow message set flagging of this entry type, APHIS requires importers and brokers to submit APHIS Core-required information for these shipments at the <u>first U.S. port of arrival</u>. Importers and brokers who are not filing electronic entries (other than in-bonds) in ACE may submit paper documents at the first U.S. port of arrival. Importers and brokers filing electronically in ACE should submit an APHIS Core message set when they submit their final entry type. Failure to submit the message set with the final entry type will result in paper clearance of the cargo at the first U.S. port of arrival and flagging of APHIS Core message set at the in-bond port of entry, duplicating work.





Section IV - Disclaim and HTS Flagging Guidance (PG01)

- IF HTS Code is flagged AQ1 then determine if LPCO's exists.
 - If AQ1 and LPCO's are not present, then disclaim.
 - IF LPCO exists, then file an APHIS Core Message Set.
 - Report all LPCO supporting documentation in a PG13/14 grouping.
 - Submit appropriate document code in DIS. See Section VII LPCO Guidance/DIS Transmission section for more information.
- IF HTS Code is flagged AQ2, then file an APHIS Core Message Set.
 - Even if LPCO's are not required as a condition of entry.
 - Report all LPCO supporting documentation (if applicable) in a PG13/14 grouping.
 - Submit appropriate document code in DIS. *See Section VII LPCO Guidance/ DIS Transmission section for more information.*
- IF HTS Code is flagged AQX then determine if LPCO exists.
 - o If AQX and LPCO's are not present, then <u>ignore the Warning disclaim allowed</u>.
 - IF LPCO exists, then file an APHIS Core Message Set.
 - o Report all LPCO supporting documentation in a PG13/14 grouping.
 - Submit appropriate document code in DIS. *See Section VII LPCO Guidance/ DIS Transmission section for more information.*

Disclaim Reporting:

Disclaim codes indicating the reason data is <u>not</u> being provided. Valid codes for APHIS:

- **A** = Product is <u>not</u> regulated by APHIS
 - HTS Code is flagged AQ1 (data may be required) or AQX (warning)
 - Importer has verified commodity is not regulated by APHIS via admissibility support.
 - Admissibility guidance and support can be found at the following web pages: (<u>https://www.aphis.usda.gov/aphis/banner/contactus</u>) or (<u>www.aphis.usda.gov/aphis/ourfocus/importexport</u>)
 - If product is non-regulated *plant-based*
 - Report <u>APQ</u> as the program for disclaim or refer to the APHIS flagged Harmonized Tariff code to category type section of this appendix for additional guidance.
 - If product is non-regulated animal-based
 - Report <u>AVS</u> as the program for disclaim or refer to the APHIS flagged Harmonized Tariff code to category type section of this appendix for additional guidance.
- **B** = Data is <u>not</u> required per APHIS guidance
 - HTS Code is flagged AQ1 (data may be required) or AQX (warning)
 - The product is regulated by APHIS, but the agency has determined the product does not need a message set or License, Permits, Certificates, or Other documents (LPCO's) as a condition of entry.

 - If product is *plant-based*

 - If product is *animal-based*
 - Report <u>AVS</u> as the program for disclaim or refer to the APHIS flagged Harmonized Tariff code to category type section of this appendix for additional guidance.
 - If product falls under USDA (Veterinary Service) Guidelines
 - Example: Most laboratory animals can be imported under USDA import guideline #1103 without a permit or certificate.
 - Report <u>AVS</u> as the program for disclaim or refer to the APHIS flagged Harmonized Tariff code to category type section of this appendix for additional guidance.





• Important Note: filers can utilize disclaim code B for commodities qualifying under a VS guideline where no certificate is required as a condition of the guideline. If the guideline requires a certificate, you cannot disclaim.

It is important to understand not all APHIS regulated commodities require submission of a message set and not all AQ1 (data may be required) or AQX (warning) flagged Harmonized Tariff Schedule of the United States (HTSUS) codes are granular enough to know if the commodities within a given HTSUS are regulated by APHIS. In other words, some HTSUS codes are too general and have both regulated and non-regulated commodities within them.

Filers are required to submit message set for all APHIS regulated commodities where the HTSUS codes have been flagged AQ2 (data is required) or flagged AQ1 (data may be required) or AQX (warning) where the commodities require LPCO's (Licenses, permits, certificates and other documents) as a condition of entry. Therefore, current APHIS policy allows filers to disclaim AQ1 commodities and ignore AQX commodities that do NOT require LPCO's as a condition of entry. Disclaims due to "data filed through paper" will not be allowed if filing CBP header data in ACE.

Nevertheless, filers <u>may</u> submit APHIS message sets for AQ1 or AQX flagged commodities that do not have LPCO's (as a condition of entry) if they believe it will facilitate the movement of the shipment. It may be beneficial to provide clearing/inspecting officers with more granular information if the commodity is regulated and routinely inspected, even if LPCO's are not required as a condition of entry. Normally this is especially beneficial if the same or similar commodities require LPCO's depending on country of origin or if commodities appear the same or similar but are regulated differently depending on composition/ingredients, Intended use, or physical state (e.g., frozen).

Note: APHIS has an OMB (Office of Management and Budget) exemption that requires the agency to continue to receive hard copy foreign issued certificates (e.g., veterinary, health, sanitary and phytosanitary) because they are considered "legal instruments" (aka, formally executed written documents) issued by foreign governments.

1.	When should APHIS Core be disclaimed?
•	For APHIS Core, disclaims are allowed when the HTS code flag is set to AQ1 (data may be required) and Licenses, Permits, Certificates or other documents
	(LPCO's) are not required as a condition of entry. Note: All AQ2 (data is required) commodities require a message set even if they do not have LPCOs as a
	condition of entry. Optional message sets can be provided even for articles that qualify for disclaim.

2.	Under what circumstances, would an Importer disclaim a product subject to AQ1 (APHIS may be required)?
•	Any circumstance that would allow the commodity to make entry without accompanying LPCO documents. Please note: Filers are opting to report message sets even if they are not required to facilitate the movement of the shipment. Using this technique allows the officer clearing the shipment electronically to quickly determine that the commodity is <u>not</u> something they are interested in inspecting. In essence it helps further identify the product within less specific harmonized tariff description so officers can identify it as not regulated by APHIS.
FAQ 3.	Which disclaim types are allowed by APHIS Core?
•	As noted in the PG01 Disclaim data element description section of the Implementation guide, disclaim code "A" (product is not regulated by this agency) and "B" (data is not required per agency guidance) are the only acceptable codes for USDA APHIS. There are no "Other Agency Means" available.

4.	How are USDA guideline statements (ex. 1100 – 1105) submitted if the commodity is eligible for disclaim? In the past, USDA will not release the shipments without submission of these documents.
•	Current APHIS policy is to disclaim commodities covered by USDA (Veterinary Services) guidelines using code "B" (not regulated by this agency) and then submit the guideline statement (aka manufactures statement) to DIS.
•	APHIS VS regulated commodities needing <u>only</u> a VS statement document (i.e. STAT) do not require a message set to be filed; however, the statement document should be uploaded into ACE DIS using the appropriate APHIS document code. Note that if a statement document is required based on requirements stated in a VS Permit, the presence of the permit requires the submission of a message set.
٠	APHIS also accepts message sets if the importer/filer believe it will facilitate the movement of the shipment. In that case manufactures statements are reported in PG13/14 and sent to DIS.

- 7) What if the product does not have Licenses, Permits, Certificates, or Other documents (LPCO's) as a condition of entry but the HTS codes is still flagged as AQ2 (data is required)?
- If the HTS codes is flagged AQ2 (data is required) then the product is still regulated by APHIS, but the agency has determined the product does not need special permission or other documents to make entry (except the message set).
- This is generally due to the commodities country of origin and/or how it was produced or manufactured. In this case the message set is still needed to certify country of origin and all other factors that in turn allows the commodity to enter the United States without LPCO's.

- 8) Will we receive a "May Proceed" from the PGA when transmitting a Disclaim?
- Filers will not receive a May Proceed for that PGA line. To be more specific a SO70 is not generated to trade (i.e., no May Proceed).

Section VI - Harmonized Tariff Codes and APHIS Commodity Category Types (PG10)

Commodity Categorization (overview)

The PG10 record line is the primary architecture used to help stakeholders correctly report commodities within the APHIS Message Set. This record line is critical for APHIS Message Sets because it supports the ability to filter and efficiently align commodities into specific groups. The main data element, "Commodity Category Type" is the top-level grouping which allows commodities or products to be lumped and/or split into specific sub-groups using the data elements associated with Commodity Categories and Commodity Characteristics. It is important to note these categories and characteristics are directly and only align with specific related Commodity Category Types. Naming and coding conventions within the subgroups always align to the Commodity Category Type which are also aligned with APHIS Programs - Biotechnology Regulatory Services (BRS), Animal Care (AC), Plant Protection and Quarantine (PPQ) and Veterinary Services (VS) - and APHIS LPCO types, as well as, cross-referenced with the APHIS "flagged" HTS codes. Filers and their software providers can use this feature to restrict choices within the broker interface so that once an HTS and Commodity Category Type is selected only the related values within the corresponding commodity categories and characteristics, as well as APHIS Programs and LPCO's, are available for reporting.

APHIS has flagged approximately 2,052 specific harmonized tariff schedule (HTS) codes that fall under its jurisdiction. This fluctuates slightly each year depending on the changes made by the United States International Trade Commission (USITC). Each HTS code is given a status of either AQ1 (maybe required), AQX (warning), or AQ2 (is required) depending on how granular the HTS code describes the various individual commodity or commodities within it. Most AQ1 and AQX commodities have broad HTS code descriptions and therefore the individual commodities covered within the HTS code cannot be identified at a granular enough level for APHIS to regulate them appropriately. Occasionally APHIS regulated commodities are imported under HTS codes that are not flagged by APHIS. In those cases, it is important to understand importers are still responsible for meeting APHIS conditions of entry and for filing an APHIS Message Set (regardless of the tariff flagging) – especially when APHIS LPCO's are required. APHIS Core publishes its latest flagged HTS codes at the following: <u>APHIS HTS</u> <u>Master Correlation Table</u>. APHIS takes reasonable steps to stay up to date with these changes. If a HTS code is not found in the list an APHIS Message Set may still be required.

Note: The APHIS Biotechnology Regulatory Service program or ABS, Category Type AP1000 is not categorized to specific HTS codes because genetically modified products are continually changing and lack of granularity in the HTS schedule. The ABS program is triggered during the filing of ABS LPCO documentation, specifically when the Permit for Movement or Release of Genetically Engineered Organisms (APHIS BRS 2000) or code A34, APHIS BRS Notification or code A35, and APHIS BRS Acknowledgement letter or A36 is declared.

Cut Flowers Name / Fruit and Vegetable/ Propagative Material Validation Lists

APHIS has released a Cut Flower (AP0800), Fruit & Vegetable (AP0600), and a Propagative material (AP0400) list to assist trade with commodity spelling verification. These lists provide genus, species, subspecies, and variety names (PG05) along with corresponding common names (PG17). These lists do not represent commodities that may or may not be admissible but provide the acceptable spellings for listed names and in some cases provide the corresponding





Integrated Taxonomic Information Systems (ITIS) Taxonomic Serial Number (TSN) and/or the APHIS Internal ID (APID). These lists are not all-encompassing; if the genus, species, subspecies, or variety does not appear on this list, use the format that appears on the associated phytosanitary certificate and commercial invoice. PPQ will update the list as necessary and provide the date of the most recent update. •	For APHIS, the top level of PG10 is the Commodity Category Type data element. Using this element APHIS has currently separated its commodities into nine separate groups.						
•	The next level down is further divided into subgroups using Commodity Categories. Each Commodity category (subgroup) follows the naming/numbering convention of its parent Commodity Category Type.						
•	The third level down is created by combining the values within Commodity Qualifier Codes and Commodity Characteristic Qualifiers. Each of these values continues to follow the naming/numbering convention of its parent Commodity Category.						
	• For APHIS the best way to think about the third level is by understanding that Commodity Qualifier Codes are utilized to qualify which type of						
	characteristic (e.g., Condition, Physical State, and/or composition) is being reported and then <u>what</u> those specific characteristics are within the Commodity Characteristic Qualifier.

•	The first to levels of the hierarchical structure (Commodity Category Type and Commodity Category) are required for all APHIS Message Sets.						

• Note: The absence of Commodity Qualifier Codes and Commodity Characteristic Qualifiers can be an inspection trigger. If the characteristics of a commodity aren't reported then CBP Agriculture and APHIS officers are required to validate things like condition, physical state, packaging, and or composition (ingredients) as a condition of entry.





Section VII – LPCO Guidance (PG13/14)

License, Permits, Certificates, and Other (LPCO's) as a condition of entry:

After the tragic events of September 11, 2001, much of APHIS' PPQ workforce was consolidated into U.S. Department of Homeland Security (DHS) to unify Federal inspection forces. As a result, CBP agriculture specialists through a Memorandum of Understanding between USDA and DHS inspect shipments of imported *non-live* **plant and animal products** and ensure that the required LPCOs accompany each shipment. LPCOs can include permits, sanitary certificates, phytosanitary certificates, certificates of origin, and health certificates, as well as, required manufacturer statements. APHIS continues to inspect imported <u>live</u> plants at Plant Inspection Stations and live animals through local port veterinarians.

By regulation, APHIS requires various LPCO's as a condition of entry. LPCO's provide CBP Agriculture and APHIS officers with the regulatory ability and authority to clear and/or inspect commodities. Some LPCO's provide key information about the commodities identity (e.g., the name, amounts, conditions, origin etc.), while others provide statements of sanitary/cleanliness, or conditions of admissibility (e.g., permission, authorization, attestation, statement etc.), while others provide arrival notification (e.g., notice of arrival, declaration of importation, etc.). Historically importers provided this information to officers "before or upon arrival" via paper [LPCO] documents. Without those documents, officers cannot release commodities into U.S. commerce. With the implementation of ACE, the prerequisite and use of these documents to clear and/or inspect commodities has not changed. The only difference is the presence (aka: existence) of these LPCO's are now being reported in PG13/14 LPCO record lines. Depending on commodity and LPCO type the information on the paper documents are being replaced entirely by the submission of the APHIS message set.





License, Permits, Certification, and Other (LPCOs) correlation to Category Type and Program Type Code

In most cases Permits and Certificates are required for entry for APHIS regulated products. LPCOs identify the type of license, permit, certificate or other. More than one LPCO type may be used. Full LPCO Type descriptions can be found on the ACE CATAIR Appendix PGA.

ACE / eFile System Integration and Permit - Reporting Guidelines:

<u>APHIS permits</u> are used as permission or prior authorization for the importation of regulated commodities into the United States. Some import permits are onetime use only while many may be used for longer periods of time. In general, they identify who holds the permit (the applicant) and what is allowed entry (the commodity), while also providing both the importer and inspector information about specific conditions of entry.

APHIS <u>eFile</u> is the online system for users to apply for and receive import, interstate movement, transit, release permits, apply for permit renewals and amendments, submit annual reports, and receive regulatory guidance. *For animal care licensing and registration, visit the <u>Apply for a License or Registration</u> <i>page.* APHIS eFile can also be used and will provide a letter of no permit if the product isn't regulated for needing a permit. Keep in mind that PPQ program permits are issued in near real time.

APHIS has successfully integrated ACE with eFile. This integration allows the agency to automatically match permit data, reported in PG13/14 record lines, with official permit records within eFile. Upon match, the official signed permit record is displayed within the ACE Document Imaging System (DIS) allowing CBP Agriculture and APHIS officers to quickly identify permitted commodities and review their "conditions of entry". This information is then leveraged to easily validate those conditions against what is reported within the APHIS message set and/or found during inspections.

"LPCO Type" and "Number" are key data elements for a successful match, because not all permits issued by APHIS reside within the ePermits/eFile system. When reporting permits issued by ePermits/eFile (Including: LPCO types = A09, A10, A11, A12, A13, A14, A15, A16, A17, A18, A19, A20, A21, A22, A23, A24, A28, A35, A36) an SO72 match / no match message will be sent to the filer. This message is <u>informational only</u> and lets the filer know whether the officer's received the permit via the automated process, which in turn facilitates the movement of the shipment. If filers receive a "no match" message, they may revise the permit number within the message set or wait to see if the officers clearing/inspecting the commodity(s) request further documentation (proof of permit).

SO72 match / no match example:

"APHIS Permit # [max 33 characters] found. Document is in DIS"

"APHIS Permit # [max 33 characters] not found. Revise #/send doc"





Foreign Issued Certificates - Reporting Guidelines:

Foreign issued certificates are usually "attestations" or "statements of fact" by a foreign government official to the cleanliness or sanitation of a specific commodity at the time of importation.

Phytosanitary certificates are used to attest that consignments meet phytosanitary import requirements and are issued by an NPPO (National Plant Protection Organization) of the foreign government. A phytosanitary certificate for export or for re-export can be issued only by a public officer who is technically qualified and duly authorized by the NPPO. APHIS accepts phytosanitary certificates that utilize the model/template designated by the Food and Agriculture Organization of the United Nations (FAO), International Plant Protection Convention (IPPC), and International Standards for Phytosanitary Measures (ISPM) 12.

Foreign inspection certificates are required to accompany all imported meat, poultry, and egg products. These certificates must indicate the product name, establishment number, country of origin, name and address of the manufacturer or distributor, quantity and weight of contents, list of ingredients, species of animals it was derived from, and identification marks. The certificate must also bear the official seal of the foreign government agency responsible for the inspection along with the signature of an agency official. This certificate must be in both English and the language of the foreign country.

Please note: APHIS has an Office of Management and Budget (OMB) exemption to continue to require some documents (like most certificates) in paper.

Document Imaging System (DIS) Transmission Guidance:

DIS allows participating trade partners to submit document Images and associated descriptive metadata to CBP and other Participating Government Agencies (PGA's) electronically. Upon successful transmission, the documents are securely stored and made available for review by CBP and PGAs. Documents submitted via DIS are in lieu of paper documents.

DIS presently provides the following document image submission and management capabilities:

- Allows Trade Partners to submit document images and associated descriptive metadata intended for CBP and PGAs in an automated manner.
- Stores all submitted documents in a secure centralized CBP database and maintains associations with transactions such as Entries and Bills and other related descriptive data.
- Allows authorized CBP and PGA users to retrieve, view, review, and annotate documents via a web-based user interface.
- Provides security, authorization, and auditing capabilities.
- Provides validation error results or receipt notification back to trade partners for each submitted document transmission.
- Provides capabilities for CBP Client Representatives to view raw received messages and audit information to assist trade partners in troubleshooting.

Please note the following, regarding how CBP and PGAs can view the documents submitted to DIS by trade:

• APHIS Core PGA documentation is added to DIS entry (aka cargo release), not DIS entry summary.





- CBP can view all documents, regardless of whether it's a CBP or a PGA document.
- PGAs can only view documents that are 'owned' by that agency per the Appendix A of this document, OR, if trade submits additional PGA agency codes that allows non-owning agencies to view the document. (For XML, the additional agencies are added via the GovtAgency data element. For email, they are added via AGENCY_CD).
- If a document is owned by a given agency, you do not need to also provide that agency's code in the above locations when submitting the document.

LPCO/DIS Correlation Table:

If LPCO's are reported in PG13/PG14 then a corresponding Document Label Code or DocCode (depending on how submitted) must be present within the ACE Document Imaging System (DIS). A filer will receive a warning message "MISSING OR INVALID DIS DOC INFO PER PGA" if the corresponding LPCO is presented in the PG13/PG14 lines but absent from DIS. Similarly, when submitting DIS Documents the Document Label Code or DocCode must correspond to what is reported in PG13/14 record lines of an APHIS Message Set. A filer will receive a warning message "PG14 DATA MSNG FOR DOC LABL CODE PER PGA" if the corresponding LPCO is presented in the DIS but absent from in the PG13/PG14 lines. The following table matches the expected DIS document code with its appropriate APHIS LPCO form name.

Note: "Original Paper Document may be required at arrival (as a Legal Instrument) = "*No" indicates original paper documentation may be needed to support proof of commodity identity, origin, condition, quantity, and volume in lieu of other LPCOs and to support information provided in DIS and/or message set during compliance exams and enforcement investigations.

A filer who transmits data or information through any electronic means to CBP certifies, by the act of transmitting such data or information, that the data or information transmitted is true and correct to the best of the filer's knowledge and belief. The filer also declares that all statements in an electronically transmitted entry, entry summary, invoice, claim, other filing, and all other information or data filed with the entry are true and correct to the best of the filer's knowledge and belief. The statements are not true and correct to the best of the filer's knowledge and belief.

Other documents

Other documents like commercial invoices, arrival notifications, and declarations are used to document and prove which commodities are being imported. They are also used to notify CBP Agriculture and APHIS when and where the commodities will arrive. Documentation about the commodity, as well as, when and where it will arrive is required by regulation and/or a prerequisite for the clearance and/or inspection process to start. Note: STATS (Manufacturers Statements) are reported in PG13/14 grouping.

•	No – APHIS has a waiver from OMB to continue to allow foreign government issued LPCO's in paper. Those certificates are considered "legal instruments" and should continue to accompany the shipment and presented upon arrival. Even though they are required in paper, a message set would still be submitted, and the "presence" of the certificate(s) would be reported in the APHIS PGA message set.						
•	When the APHIS message set becomes "mandatory" (aka flags are enforced) filer using ACE to file header data will need to file APHIS message sets where appropriate. In short if filers use ACE, then they will report message sets for APHIS. Only a full paper filing would allow paper for APHIS core.						
•	Note: We are working with foreign governments on a project that would have them send certificates directly to APHIS and ACE. When implemented the importer and filer would only need to report the number of the certificate within the message set. The number would then automatically match the certificate within ACE and be displayed for the officer. APHIS has implemented a similar process for our ePermits, eFile/ACE integrated system.

4. We have a customer that imports some fresh vegetables. The two forms we get are the Certificate of Origin for Fresh Tomatoes and Certificate of Origin for Fresh Peppers. Neither of these have a document ID or control number or issuing government agency. The customer is struggling to determine if there are any other forms that need to be reported through APHIS Core or if they are message sets or disclaims.

- For the PG13 "Issuer of the LPCO", please use the exporters company name. This is a mandatory field but isn't only used for the foreign government's name.
- The LPCO number in PG14 is mandatory but "Certificate of Origin" or "COO" can be reported instead of a number.
- All fruits and Vegetables are flagged as AQ2 so no disclaims are allowed even from Canada.

FAQ

- 5. Does the actual USDA Import Permit have to attach to the entry or just the number of the permit? How will be broker know if the permit number is matched?
- Only the permit number is required. APHIS has successfully integrated ACE with ePermits (the agencies biggest permitting system). This integration allows the agency to automatically match permit data, reported in PG13/14 record lines, with official permit records within ePermits. If a permit match does occur, an SO72 message will be sent to the filer to let them know that the permit was found in DIS. If a permit match does not occur, an SO72 message will also be sent reminding the filer to re-submit a correct permit number or to supply a copy of the permit via DIS.

FAQ

- 6. I understand that if the product is subject to AQ1 and has an LPCO that a full message set is to be submitted via ACE. That said, could you please elaborate on what you mean by O (Other). What document would be considered Other?
- For APHIS (Core), the "Other" of Licenses, Permits, Certificates, Other (LPCO) means Manufacturer's Statements, Owner/Importer Statements, Producer Statement, shipper statements, and other such "statements" that are needed for import admissibility of certain APHIS-regulated commodities. APHIS VS regulated commodities needing only a VS statement document (i.e., STAT) do not require a message set to be filed; however, the statement document should be uploaded into ACE DIS using the appropriate APHIS document code. Note that if a statement document is required based on requirements stated in a VS Permit, the presence of the permit requires the submission of a message set.





Section VIII – Entity Role and LAP Guidance (PG19/20)

Entity Role Reporting:

APHIS Core global rules requires PG19 Entity Role Codes Ultimate Consignee (UC), Customer Broker (CB) or Importer (IM) only if IM is the filer, LPCO Authorized Party (LAP), and if certain conditions apply Permitted Destination (APD), and Crop Grower (DFI). The APHIS global rule also accepts USDA Offshore Greenhouse Certification Program (AG1), Manufacturer (MF), Producer (GD), Packer (PCK), Processing Establishment (PRO), Ranch/Farm (RCH), Shipper (DEQ), Slaughter Establishment (SLA), or Consolidator (CR). When submitting PG19 Entity Role codes they must correspond to one of these codes. A filer will receive a <u>reject</u> message "MSNG OR INVLD ENTITY ROLE CODE PER PGA" if the PG19 Entity Role code does not correlate to one of these PG19 Entity Role codes accepted by the APHIS CORE Message Set.

In addition, APHIS recommends reporting of grower, producer, manufacture or similar, to verify commodity source, expedite document review and clearance. IF PG10 Commodity Category Type(s) = AP0400, AP0500, P0600, AP0800 OR PG10 Category Code = Cones (705) OR = Grains (708) OR = Grasses (709) OR = Herbarium specimens (712) OR = Insects, earthworms, pathogens, and snails (713) OR = Nuts (714) OR = Lumber (723) OR = Logs (724) THEN, the PG19 Entity Role Codes shall also include at least one of the following grower, producer, manufacturer or similar codes: AG1 OR DFI OR RCH OR MF OR GD OR PCK OR CR OR PRO. A filer will receive a <u>warning</u> message "MSNG OR INVLD ENTITY ROLE CODE PER PGA" if one of these corresponding PG19 Entity Role codes is not present in the APHIS CORE Message Set for these commodity types.

LAP (LPCO Authorized Party) Reporting:

The LAP (LPCO Authorized Party) varies depending on LPCO type. In general, this is the "issued to party" or "holder" of the LPCO. For APHIS permits the LAP is equivalent to the permittee, while certificates generally use the term "issued to party". In some instances, certificates have two parties listed, therefore the entity who conveyed (requested or paid for) the certificate should be used. This is normally the foreign party/entity present at the time the document was created and signed by the foreign government official. The reporting of multiple PG19 LAP entities is accepted. However, unless the issued to party or holder of the LPCO is different from other LPCO's being reported, APHIS only requires <u>one</u> LAP per message set regardless of the amount or type of LPCO's required as a condition of entry listed in PG13/14. In other words, filers only need to report one LAP if the entity is the same across all LPCO's.





Section IX – Unit of Measure Matrix by Article Category Type (PG26)

While Packaging Qualifiers describe packaging from the outermost to the innermost package, APHIS does not use this ordering convention and only needs up to three units of measure reported in any order with any sequence of packaging qualifier. A filer will receive a reject message "MISSING OR INVALID UOM PER PGA" if the PG26 Unit of Measure does not correlate to one of the PG26 Units of Measure accepted by the APHIS CORE Message Set. The following unit of measure matrix table matches the PG10 Commodity Category Type and Category Code with its expected unit of measure.
