# ACE Validation of FIRMS Codes for In-bond Arrivals, Excluding Air Mode of Transportation (MOT)

Last updated: August 6, 2024



On **August 10, 2024**, U.S. Customs and Border Protection (CBP) will deploy enhancements to the Automated Commercial Environment (ACE) to validate the Facilities Information and Resource Management System (FIRMS) codes for in-bond arrivals, excluding arrivals by air. This enhancement will, for non-air modes of transportation, enforce existing requirements that brokers/filers provide a valid FIRMS code when arriving an in-bond. This enhancement includes Electronic Data Interchange (EDI) impacts.

### What will change for trade users?

- Effective November 27, 2017, CBP requires that within two business days after the arrival of any portion of an in-bond shipment at the port of destination or the port of exportation, brokers/filers must notify CBP via a CBP-approved EDI system that the merchandise has arrived. The notification must include the FIRMS code of the physical location of the merchandise within the port. (See: 82 FR 45366; 19 CFR § 18.1(j) Report of arrival)
- With this enhancement, ACE will <u>verify</u> that the FIRMS code is provided, is valid, is active, and is within the in-bond arrival port.
- In addition, for locations that require a bond, ACE will verify that the correct bond type is in place for the FIRMS code. Brokers/Filers are reminded to ensure the appropriate bond is secured and associated to the FIRMS code prior to this deployment.
- Failure to enter a valid FIRMS code for non-air modes of transportation will result in an error and the arrival will not be transmitted to CBP.
  - o **Manifest Trade In-bond user interface (UI):** When the Manifest Trade In-bond UI is used to submit an in-bond arrival without a valid FIRMS code, the user will get an error.
  - o **EDI transmission:** When EDI is used to submit an in-bond arrival without a valid FIRMS code, ACE will return the following error codes:
    - Ocean and Rail: 157 (FIRMS CODE REQUIRED)
    - Truck: 157 (FIRMS CODE REQUIRED), 158 (FIRMS CODE NOT ON FILE), 159 (FIRM NOT ACTIVE), 164 (FIRM NOT ON FILE FOR DDPP).
    - Foreign Trade Zone (FTZ): 028 (FIRMS CODE NOT ON FILE).
- Failure to report the arrival of the merchandise transported in-bond within the prescribed period constitutes an irregular delivery.
- At this time, in-bonds originating in Air Mode of Transportation (MOT) will not be affected by this FIRMS code validation update, regardless of the in-transit MOT. CBP is working to deploy this validation across all MOTs at a future date.

## Accessing the Manifest Trade In-Bond ACE Portal user interface

- The Manifest Trade In-Bond UI is one way trade users can arrive, export, divert, and cancel arrival and export of in-bonds.
  - o NOTE: This UI is only accessible from the Carrier Account view.
- To access the Manifest Trade In-bond UI, trade users need an ACE Secure Data Portal (ACE Portal) account. To apply for an account, follow the steps outlined on the <a href="Applying for an ACE Portal Account webpage">ACE Portal Account webpage</a>.
