# Background:

The El Paso Sector operates in two different Federal District Courts (Western District of Texas and the District of New Mexico) which have their own unique procedures and guidelines. El Paso Sector (EPT) has a centralized prosecutions unit for the Western District of Texas and individual station specific prosecution units for the District of New Mexico.

On April 11, 2017, United States Attorney General, Jeff Sessions directed all Federal Prosecutors to renew their commitment to criminal immigration enforcement. AG Sessions made it a high priority for the Department of Justice to establish lawfulness in the immigration system, specifically for immigration offenses.

Meetings were held between El Paso Sector leadership and members from the Assistant United States Attorney's Offices (AUSA) in Texas and New Mexico to discuss how the guidance from AG Sessions might impact both USBP operations and the AUSA's ability to support those efforts.

#### Prosecutorial Efforts - Texas:

The El Paso Sector maintains a good working relationship with the Assistant United States Attorney's Office in El Paso. There are currently no restrictions imposed for EPT Border Patrol prosecutions within the Western District of Texas for either Misdemeanor 8 USC 1325 or Felony 8 USC 1326 cases. The TX AUSA however, has requested agents contact the Duty AUSA to request prosecutorial approval for each case by providing a synopsis of the arrest narrative containing all pertinent details of the case.

On July 11, 2017, the El Paso Sector expanded the separation of Family Units (FMUA) for all TX BP Stations in response to an internal assessment which revealed a significant increase in FMUA entries. Chief AUSA (b)(6);(b)(7)(C) agreed to prosecute all amenable adults who entered as part of a family unit. Prior to this agreement, FMUA separation was limited due to the fact that parents were required to have prior criminal and/or immigration history before separation was approved. Current guidelines now allow for all Family Units to be separated.

#### Family Unit Assessment:

In late January 2017, the El Paso Sector experienced a significant decrease in the number of FMUAs seeking to enter in the EPT Area of Responsibility (AOR). Soon after the initial decrease in late January, a steady increase began in the number of FMUAs making entry in the

EPT AOR. EPT conducted an internal assessment to measure the increase and assess the potential impact to field operations.

Based on the trend identified through the end of the 3rd Quarter, there was an average of a 50% increase in FMUAs per month through the end of June but there was another significant drop in July.

- April (318) to May (496)
  - o 56% increase between April and May
- May (496) to June (709)
  - o 43% increase between May and June
- June (709) to July (307)
  - o 59% decrease between June and July

After meeting and coordinating with the TX AUSAs Office, the El Paso Sector began aggressively separating FMUAs on July 11, 2017. It is still too early to determine the extent of the impact this action has had, but preliminary indications are that increased FMUA separation has impacted the Texas FMUA totals significantly:

## Family Unit Separation Process:

Upon approval to separate, the parent is processed through the court system while the child is treated as an unaccompanied juvenile and processed through the Office of Refugee Relocation (ORR).

Once the child is turned over to ORR the following occurs:

- ORR provides complete services for the children, to include medical screening and care, education and counseling (as needed) to deal with any separation issues
- ORR identifies potential suitable sponsors for the children; sponsors are limited to immediate family members (uncle/aunt, grandfather/grandmother, older brother/sister, etc)
- Sponsors are vetted to ensure they can adequately care for the child/children
- If a sponsor is identified and approved, travel arrangements are made and the child is accommodated with any necessary support and assistance (Medicaid, food stamps, etc.)
- If a suitable sponsor cannot be found, the children remain in the care of ORR until:
  - Reunification and repatriation can be coordinated with the parent(s), arranged by ORR and ERO
  - o If re-unification cannot occur due to venue and/or time limitations, ORR will search for a family member in the child's home country, if family is located, the

- child will be repatriated to the family member in their home country ORR and ERO will work with the home country's consulate to coordinate repatriation
- o If a family member cannot be located in the home country of the child, ORR and ERO will work with the home country's consulate for repatriation purposes
- o If arrangements cannot be made with the consulate, ORR has the ability to place the child/children into long term foster care

Once a child is in ORR custody, Border Patrol has no access to the child. The phone number to ORR is given to all parents who are prosecuted in an attempt to later simplify reunification if the parent opts for reunification since most allow the child to continue placement with a sponsor in the U.S. All foreign consulates have the contact information to ORR.

#### Prosecutorial Efforts - New Mexico:


The El Paso Sector also maintains a good working relationship with the Assistant United States Attorney's Office in New Mexico. After several meetings and discussions, on July 6, 2017, Acting United States Attorney Jim Tierney agreed to remove all restrictions imposed for EPT Border Patrol prosecutions within the District of New Mexico for either Misdemeanor 8 USC 1325 (only 25 per month) or Felony 8 USC 1326 (a)(1) cases (only 150 per month). This action allowed New Mexico BP Stations to prosecute all amenable subjects in an effort to increase the consequences of entering in NM illegally in the hopes of deterring first time and/or repeat offenders. This was a significant change in policy for the District of New Mexico as outlined in the chart below:

Ma'am,

I spoke to our leadership regarding your email and our conversation yesterday. We are very happy with the fact that 1326 (a)(1)s are no longer restricted to 150 cases per month and we definitely appreciate your support to that end. Unfortunately, we are concerned with the aggravating circumstances a subject must meet before we can proceed with prosecution for 1325. Based on the current list you provided below, we don't feel there will be any change to the number we currently prosecute, which is concerning to us as this number is extremely low in direct comparison to the number of subjects who could be amenable to 1325 prosecution.

As it stands, we never reached the 150 threshold for 1326(a)(1) cases and don't anticipate an increase in the number of those cases. With the restrictions still in place for 1325's we won't gain any leverage to deter entry by illegal aliens in New Mexico. As a possible XXX we would propose the following as an alternative:

All previously required aggravating factors listed in the email below will not be needed to prosecute for 8 USC 1325 during this timeframe. This will be temporary (through the end of pay period 09) and will allow the NM ASUA's Office's to measure their ability to support 100% prosecution with their current staffing. At the end of the pay period, we will meet with the AUSA's Office to assess the results and discuss a path forward.

This targeted action will not be subject to the aggravating factors listed above but must be coordinated and planned prior to execution. Station IPT's will submit their CONOP to LEOD. The CONOP will include the following: targeted zone(s), date range, justification and list of anticipated resources required to conduct this action. SHQ PROS and SHQ IPT will coordinate with the NM AUSA's Office prior to approval and commencement of any "Targeted Zone Prosecutions".




