The subject stated to (b)(7)(E) that he was a student coming to study at (b)(6)(b)(7)(C) During the secondary inspection, it was discovered that the subject may be sympathetic to multiple foreign terrorist organizations. Several images were discovered on his Facebook account of the AL-QASSAM

BRIGADES (military wing of HAMAS), as well as HEZBOLLAH flags and multiple images of HEZBOLLAH leader Hassan NASRALLAH and various other anti-Israel images. Hezbollah, Hamas and the Al Qassam Brigades are all designated foreign terrorist organizations. The subject was also found to be following a CAT-5 (group member) TSDB online. Both subjects were processed for Expedited Removals pursuant to INA Section 212(a)(7)(A)(i)(I) (immigrant not in possession of a valid immigrant visa) and departed the U.S. on the next available flight.
