Introduction

This document provides the PGA-related output codes associated with the SO70, SO71, WO70, WO71, and PO70, PO71 records of the following CBP documents:

- Entry Summary Status Notification
- Cargo Release Status Notification
- Status notification for Stand-alone PE data submission
- ACE Cargo Manifest/In-Bond/Entry Status Query
 - o The WO70-71 records mimic the ACE Cargo Release Notification records (SO70-71). Please refer to the SO70-71 section of this document for valid PGA output codes for the WO70-71.

The PGA-related output codes have been removed from the above documents and now appear in this document. References to this document have been made in the above documents, where the codes were removed.

This document is intended to streamline future updates to the PGA-related output codes, without needing to update the above individual documents each time. Instead, this single document will be updated.





SO70 Output Related Codes

Valid PGA Entry Level Status codes

PGA Entry Level status represents the cumulative effect of all stakeholder PGA reviews on a given Entry.

If, on a single Entry, any PGA line with Prior Notice (PN) data is rejected by FDA, then trade will only receive the information related to the PN reject(s). Trade will not receive PN confirmation numbers for PGA lines in this situation that may have been accepted. Trade must cancel and resubmit the entry with the updated PN data.

If an agency's Intensive or Document Required is resolved by CBP, trade may not receive this SO70 notification of Satisfied or Resolved (12, 13) by PGAs. However, the SO60 message with the entry's status will always be sent.

Note that Codes 10, 11, 12 and 13 indicate activity at the Entry level. The PGA line number, if provided, is only for information.
