SUBJECT: Executive Order – “Protecting the Nation from Foreign Terrorist Entry to the United States” Signed March 6th, 2017.

Today the President signed a new Executive Order entitled [Protecting the Nation From Foreign Terrorist Entry Into the United States](#). The new Executive Order is effective at 12:01am EST on March 16, 2017 at which time EO 13769 will be rescinded.

Please note that until the effective date of the new EO, as stated above, the Commissioner’s guidance from February 3, 2017 – directing that U.S. Customs and Border Protection suspend any and all actions implementing specified sections of the previous Executive Order 13769 – remains in effect.

The Commissioner of CBP has directed OFO to establish an Operations Action Team to monitor the Agency's implementation of the President's Executive Order. The Team will support the field with policy and guidance, directing Congressional/Media inquiries, and to serve as a conduit on the CBP's implementation efforts. The Operational Action Team will be led by Executive Director Todd Hoffman.

Pending further guidance on the new Executive Order, Field Offices will continue inspection and processing of travelers in accordance with standard policy and procedure. CBP fully supports unified vetting and screening standards articulated in the Executive Order and stresses the need for continued vigilance to identify and prevent the entry of those people who pose a threat to the United States.

Due to potential media interest as a result of the Executive Order, Field Offices are requested to notify the Executive Director of Field Operations, the Executive Director of Admissibility and Passenger Programs, and the Operations Action Team of any adverse action processing of nationals from the six impacted countries between now and March 16 implementation.
